NEWSLETTER

Environmental Planning

The preparation of the environmental input to the **Penampang Land Scheme Plan** will be undertaken in October and November, with the support of international and local consultants. A network group consisting of ECD, Penampang Municipality and Town and Regional Country Planning Department have been established

The short-term **human resource development plan** are nearly finalised, and will be submitted in October.

The preparation of the **environmental indicator report** have been begun. Ms Siambun, WWF, has supported the department in the collection of data, and the next step will be an interdepartmental meeting. It is foreseen that the Indicator Report will be linked to the preparation of the environmental input for **the Structure Plan for Sabah**, which is undertaken in collaboration with the Town and Regional Country Planning Department. A revised TOR is under preparation.

It was decided to postpone the international **study tour** to next year. Instead regional study tours might be planned for the coming period.

Environmental Impact Assessment (EIA)

The **EIA Handbook** have been finalised and will soon be available in a printed version.

The **Guideline for River Sand and Stone Mining** has been finalised. Furthermore has a draft **River Sand and Stone Mining Policy** been prepared together with a **pamphlet**. These 3 documents have been used for an internal training session, and will soon be distributed to and discussed with all relevant authorities and associations.

A second draft of the **Guideline for Forest Activities** is under preparation, and when finished will be used for internal training, and be distributed to and discussed with all relevant authorities and associations.

The first draft of the **Guidelines for Oil Palm Plantations** has been finalised.

The 3th draft of the **Construction on hillslopes** has been finalised, and a draft **Construction on hillslopes policy and pamphlet** is under preparation. When finalised in September these 3 documents will be disseminated to all relevant stakeholders.

An EIA guideline for Local Authorities is under preparation. The guideline will include for example legal

requirements for EIA, guideline for submission of Development Plans and land applications and recommended environmental mitigations measures to be used by the Local Authorities.

Monitoring and Enforcement

An Environmental Investigation, Administrative Enforcement and Prosecution Manual has been drafted, and is presently being used for training purposed within the Department. Following this the Manual will be disseminated to and discussion with relevant stakeholders.

A **M&E training package** - based on the draft Manual and the M&E Strategy & Action Plan - has been prepared and is under implementation. A two-day **interdepartmental workshop on Negotiation and Communication** has been implemented.

A **Sabah-Sarawak cooperation project** has been planned. The aim of the project is to develop Regulations **of Waste from Pig Farming**. The project will include seminar, study tour and work shops.

The Monitoring & Enforcement Strategy is presently being reviewed and will be finalised in the coming period.

Communication & Awareness

An ECD presentation folder, pamphlet and poster and an ECD-CAB pamphlet is under production.

The production of an **Environmental Video** has been initiated and will be finalised in the coming period.

A **Clean the Moyog River Awareness Campaign** has been supported. The campaign is undertaken in cooperation with Penampang Junior Chamber and Daily Express. Posters, stickers, school competitions, news coverage, forums, river cruise are example of activities undertaken in the campaign.

Environmental Information Systems (EIS)

The **ECD Homepage** has been launched and is now regularly updated by the Department staff.

IT infrastructure has been established for the implementation of the **Management Information System (MIS)**. Training has been provided for all staff. The

Departments initial requirement for the MIS has been analyzed and documented, and a local consultant will be contracted in the coming period

GIS training has been provided for a number of ECD staff in the previous period (3 days a week for 1 month), and GIS will be applied to the preparation of the environmental input to the Penampang Land Scheme Plan in the coming period.

Administration

The **ISO documentation** materials will be submitted to SIRIM by October.

A number of publications for the **resource centre** has purchased.

Inputs and miscellaneous

Consultants used in the previous period include the CTA, Tony Greer, Flory Siambun, Mohammed Sinoh, Lim Peng Siong, Zaffeer Kiprawi, Beth Baikan, PCChang and Sri Computer.
